

Food Safety Certification Training & Exam For the Medical Cannabis Community

Sponsored by SF Environmental Health, SFDPH

Who Should be Certified?

SF Dept. of Public Health regulations for cannabis dispensaries require food handler certification for anyone making an edible cannabis product distributed at **more than one** facility in SF. The certification exam is the same exam taken by food service workers as mandated by Cal. Food Safety Law, so topics covered will be mainly traditional food safety.

Topics Covered in the Training:

The all-day training covers causes of food poisoning, prevention, time & temperature controls, cross contamination, cleaning & sanitizing, pest control, and best practices for home preparation of edible cannabis products. Participation in the training does not guarantee passing the exam.

CLASS INFORMATION

Class and exam will be held on **April 29, 2010** at **1390 Market Street, San Francisco, CA 94102**. **Class** starts at **8:30am and should end by 5:00pm**. This particular class, in addition to traditional food safety, will address edible cannabis product production as well, and is being offered to those who prepare edible cannabis products for distribution at more than one cannabis dispensary. The class is offered in English; however, if you are enrolled and you would like to take the WRITTEN exam in Vietnamese, Korean, Spanish, Arabic, or Japanese, you must CIRCLE that language on the Name Line of the registration form below and enroll for this class in advance. **Please note that this class will only be held if 15 or more people register.** You will be notified 3 weeks before the scheduled date whether or not the class will be held. If the class is canceled, your checks will be returned to you. You will still be able to receive traditional food handler training through this Health Dept.

If you enroll for the all-day class, traditional course study materials and your enrollment confirmation letter will be sent to your mailing address. **No study materials will be sent if you enroll for Exam Only.** If you have any questions, please call Larry Kessler at 415- 252-3841.
