

Manager's Food Safety Certification Training and Exam

Sponsored by SF Environmental Health

Who Should Be Certified

- Each retail food facility is required to have at least **ONE** person with a Manager's Food Safety Certification. The certified person is responsible for teaching other employees proper food handling.
- This is **NOT** the Food Handler Card training that is required for almost all food handlers in California.
- To be certified, you only need to pass the exam; you do not need to take the class. However, the exam is difficult (85 questions; passing score is 75%). The class covers the causes of and methods for preventing food poisoning, such as time and temperature controls and utensil sanitation methods.
- Certificate is valid for 5 years.

- Choose an exam date very carefully. **Rescheduling is possible with a penalty of \$45**, unless you have proof of a family emergency or verifiable medical condition. \$15 to SF Environmental Health, \$30 to NRFSP
- **Circle and indicate your 1st and 2nd choices for class and exam date. English classes fill approximately 8 weeks in advance. We reserve the right to register you in the first available class date if your 1st and 2nd choices are not available.**
