2. Check In – COVID 19 Responses [Discussion and Possible Action] – 15 minutes

Joi – shout out to Larry McClendon on his work related to COVID testing, vaccination, unhoused; shout out to Veronica Shepard prior and during COVID and always saying to looking at equitable approach with this work.

Jonathan – Roberto and I are working on focus groups about the hesitancy of vaccine in Black/African American, Latinx and Asian groups, speakers bureau; after the focus groups have been completed, important to get word out about vaccine; doing a lot of work for seat 4-5.

Janna – shout out to Larry's efforts to helping to offer CBO staff working in BVHP access the vaccine. Larry

shows what equity means; doing things to ensure that people have access not just to vaccine, but for food, healthcare, etc. Larry has shown good examples of what that means and everyone has been doing that over the past years. Beautiful to see not just talk but action.

Larry – appreciate compliments; he works hard because of SDDTAC and community members and shout out to members when pandemic started, we didn't know a lot of information and our group sprung into action for feeding funds and quick decision really paid off today, it was the foundation and feels confident due to the work that we all do. Sometimes it takes the weekends to complete the work, hats off to all committee members.

Veronica – ditto to Larry's comments. Everyone is pretty tired and nobody anticipated the pandemic to go this long and there are so many on this call. We are individually great due to the work we are doing collectively. We all figure it out somehow someway. Its been a long ride, always in my good thoughts and prayers and continue to be authentic; proud to be part of this team.

Linda – RPD is opening up 2 more community learning hubs in the Mission, Garfield Park in Golden Gate Park at the renovated tennis center for BVHP and Fillmore kids.

Michelle – DCYF continues to coordinate food services at community learning hubs, served over 100,000 meals since September 2020.

Irene – Oral Health continues its partnership with SFUSD to put oral health supplies in school meal distribution.

Miguel Carrera – Working with coalition of homelessness; would like to share about COVID, how difficult it was to work on the front line with people experiencing homelessness and they decide to go to SIP hotels which we want to convert into permanent housing. One of the biggest things we are facing is to communicate with families and children and so it more difficult to be in touch with them and find out different ways to be with them.

5. General Public Comment – 10 minutes

Kim Levine – [slides shared] Program manager at SFUSD, soda tax funding has been great and unfortunately it was cut this school year. If funding does not move forward, they will be down two health workers and 1 nurse for oral health staff support. The soda tax funding and dental

transformation initiative shared data from September – December 2020. Partnerships have been integral to oral health work.

Monica Ferrey – Thanks to SDDTAC for the decisions to make and made a difference in the communities and testing sites, vaccine education and outreach, and food distribution and find ways to get kids with learning and find ways to correlate together and appreciate your work.

## 6. DPH Staff Report [Discussion and Possible Action] – 10 minutes

Staff expressed, for many of you, this is your last meeting and grateful for your service. We have had multiple people apply for the vacant seats. The Rules Committee meeting is tentatively set for 2/22/21 and will go to Board of Supervisors for new members would be ready it to be seated for March meeting and staff would like to propose at the March meeting to do new member orientation during that window and remaining members to join first half hour and orientation for new members.

## 7. Food Security Taskforce Presentation, Paula Jones & Cissie Bonini [Discussion and Possible Action] – 15 minutes

Jonathan welcomes Dr. Jones and Cissie. Dr. Jones shares that food insecurity impacts not only an individual but an entire household. Prior to COVID 19, 1 in 4 San Franciscans are living in poverty. Paula - Food Security – lack of food, lack of nutrients and lack of food leads to human suffering. Food is critical to achieving city goals; addressing inequities and health disparities and you can't achieve city wide priorities if food is not included. COVID 19 has exacerbated food insecurity. In SF, 262,500 have filed for unemployment and 65,000 are looking for work or left the labor force. Human Services Agency conducted a Pandemic Needs Survey in May and sent to 115,000 families. The southeast sector had the highest need for food and correlated to the highest rates of COVID 19. Responses from the survey outcomes showed that food needs were higher in communities of color and families with children and mixed immigration status households.

Cissie presents COVID food response. There was an immediate need for food in city and food insecurity tripled. Organizations had to retool their funding to do this work. Critical for the future and with these new interventions that are community led interventions, SROs and restaurants. There was also flexibility with philanthropic organizations. Cissie shared the Food Security Taskforce's strategic priorities prior to COVID and taskforce is expected to sunset in June 2021 and will need to reauthorize. The Taskforce 2021 recommendations are to continue the focus, flexibility and funding.

Member asked if there are any plans to creating new partnerships so that food distribution can be spread out and targeting pockets of communities that are hard to reach. Paula responds that there has been a lot of food coordination that never happened before and one of the recommendations, it involves more partnerships and CBOs that can work with smaller communities, however there is no strategy at this point especially for the funding for the new fiscal year. Member expressed that EAT SF has had tremendous impact on families and was responsive with vouchers and gift cards from Give2SF. Hearing from several partners, there is a fear that the intention is to go to new issues, should we be aware of any? Cissie responded that it is important that response needs to be centralized and share measures of resources that are needed and to keep pulse of what

is needed and the challenges. Member shares that central coordination is helpful and to be mindful and connected to what is happening on the ground; seeing folks on the ground who knows what community members need and to create strategies that lean heavily on community wisdom and power. Member thanks Paula and Cissie for presentation, and ask if presenters see the possibility of capitalizing on the infrastructure of food distribution to help with vaccine distribution without impeding on the work being done on food distribution? Paula responds that some sites have incentivized with COVID 19 testing. There is a desire to do but many groups are wondering where the funds would come from for the food distribution.

8. Mid Break Stretch – 5 minutes
9. SDDT FY 21-22 and FY 22-23 Budget Recommendations – [Discussion and Possible Action] - 45 minutes

Co-Chairs meet with Shalini Rana yesterday to identify Mayor's priorities. Jonathan shared that mental health, workforce development and food security are in alignment with SDDTAC. The budget amounts are projections and will not know until March if the soda tax revenue has increased or decreased, once it is known, co-chairs will meet with Shalini Rana again and can provide Shalini context of SDDTAC budget recommendations. Joi shares that the Mayor's Office mostly likely will not support any new programs or projects, however workforce development and mental health are in alignment. In the past once SDDTAC recommendations have been submitted there has been no questions for SDDTAC and co chairs emphasized the importance to seek questions from the Mayor's Office in order to provide context when the Mayor's Office makes their decisions. Member thanks co chairs for speaking with Shalini on identifying priorities that are in alignment. Member adds to document where the programming is attending to and to gather what is happening with community members, such as mental health and to stay grounded in SDDTAC convictions. Member noted the importance of providing clarity on recommendations so that members are not surprised when recommendations are released by the Mayor's Office. Member suggests to keep reminding the Mayor's Office of food, oral health, etc impacts mental health.

- a. Draft FY 21-22 Discussions

Subcommittee co-chairs share their subcommittees budget recommendations.

Michelle shared that the Infrastructure subcommittee agreed with including mental health as a strategy but could not decide on amount. Funds were taken from the SFUSD student led coordinator and oral health school based programs due to uncertainty of schools reopening. Food access was based on Mayor's allocation last year. Water access was not included due to COVID impact and allocated differences to RPD Requity.

Vanessa shared that the Community Input Subcommittee decided to stay with the original SDDTAC recommendations and increased CBO grants partly to make up for the gap in decreased funding that CBOs experienced last fiscal year. Subcommittee members agreed to integrate mental health to

strategies of funded CBOs. Subcommittee members expressed the need to continue support at SFUSD and to prioritize oral health and food access.

Saeeda shared that the Data and Evidence Subcommittee agreed to the original recommendations to CBOs at \$3.5Mil level. Line items for SFUSD to keep school food and student led work doing nutrition and mental health, and stipends to youth and social justice. Continuing to recommend food access to food purchasing to \$1.2Mil. Oral health kept whole and water access - \$100K for public spaces. For RPD, subcommittee looked at how to readjust the funds to support. Member added that access to clean water in school district and have heard from homelessness advocates have barriers accessing clean drinking water.

Member added that all subcommittees are in agreement with SFUSD line and that if students are leading anything it will be about mental health. Member asked if food access funds are being duplicated and whether there are other funds from SFUSD that can possibly relocated due to schools being mostly closed? Paula Jones responds that the Healthy Purchasing Food Supplements program is not duplicative and matches funds for Cal Fresh purchases at Alemany and Heart of the City Farmer's Markets. Last fiscal year carry over funds have been expended via grocery vouchers to CBOs and Family Resource Centers. Member reminds committee of what it means by duplication, whereas there is a significant amount of people who are food insecure. Member adds that the school district is certainly feeding the students and historically SFUSD nutrition programs has been underfunded. Member reminds committee about putting forth our recommendations based on committee values and convictions. Member adds that committee made commitment that it would advocate on behalf of communities despite who is in office and this year is a very different year and every year is different and to stand by our communities. Member adds that work being done at RPD is in the strategies the committee has put forth and will continue to do so. Co-chair adds that committee members have been doing the work and continue to do and there is no attach on any city department or CBO, it is important to go back to our budget recommendations line by line with healthy discussion. Member reminded members that community has advocated that half of revenue should go to CBO line. Member adds that CBOs have historically been underfunded and to put a focus on CBOs and to put into context as these funds is an important source for CBOs and often times work is unseen.

### Public Comment:

Carlos, Coalition on Homelessness - water access in the Tenderloin is important. COVID has made it harder to access water, in addition to help cleaning oneself; before COVID there was a severe lack of access. Currently there are only 3 hydration stations in the Tenderloin asks for SDDTAC to recommend funding for 3 additional water sources in the Tenderloin that are permanent, accessible, outside where folks can access and not in parks. Carlos is willing to talk with SDDTAC on this issue.

Kati Lopez – Mission Oral Taskforce Coordinator – in this last fiscal year in addition to media campaign we have pivoted to address COVID 19. Distributed food and gift cards to community to ensure food security and to bring the importance to maintain oral health and documentation of

barriers to access dental care or services from medical service. Thinking about how the community is asking how to maintain oral health through oral health supplies and education.

Katie Ettman – SPUR; excited to hear to uplift SDDTAC and to remind committee there were nearly \$3Mil that went towards general fund programming and it wasn't tracked and would encourage to make strong budget recommendations and to encourage the Mayor and Board of Supervisors to track general fund for communities and to identify what this revenue was intended to do.  
Appreciate the focus on mental health, students, 0-5 and mothers.

Flo Kelly – Human Rights Workgroup of the Coalition on Homelessness and focus on discussions on the homeless in the Tenderloin and amount of water they have access to and would like to refill their bottles in more places that exist now. PUC has agreed on 3 permanent places to have sources of water and need 3 additional installed so people know where water will be. Unhoused neighbors barely have access to water. Goal is to do work in the Mission and Bayview districts, and it is where homeless populations are at. Hope you recommend funding public water access.

Kim Levine – Results from Dental Transformation Initiative and soda tax helps support the work. No impact data until recently and showing that 0-5 has gone up 10%; nurse has been sitting on all committees that exist in regard to oral health. Greatly appreciate if funded, otherwise two positions would go away if not funded, less oral health support and this funding has made a huge difference.

Dental data is referencing children ages 0-5 on MediCal.

Kent Woo - NICOS - Thanks to SDDTAC for the work they have been doing and happy to see that oral health taskforces were funded; Prior to the pandemic the taskforces has conducted outreach and oral health education and has pivoted with working with school district and CBOs to conduct education while families are in for food distribution. There has been outreach to SROs and handed out oral health kits, this was a way to bring oral health care to where people are since people were fearful of leaving the building. There has been some work to set up with SFUSD to do oral health presentations to students online.

Blythe Young – thank you and echo Roberto about water access despite pandemic, especially for folks within the unhoused community and it is vital for their health. In addition the need to track the general fund so that is public record and making sure there is accountability of to the original intent of the tax is for.

Larry Ackerman– retired UCSF research scientist and works with Coalition on Homelessness. Commends SDDTAC on recommending that students have adequate water and that many students are homeless on the streets and they deserve water just the same as those students who go to school. Carlos, Flo and Roberto have laid out coalition plan for this fiscal year and would like to bring it home to a personal situation. Husband lived on street for 5 years, first thing he wanted to do was use the bathroom and then have something to drink; spending money on water or sugary drinks quickly depletes funds for food. Quite often if you are 6 blocks from water that is quite an

effort to get more water. He died with a water bottle next to him on the streets in October.

Susan Fisher-Owens – Thank you for all of your work on behalf of our citizens. As a pediatrician to an underserved community and community member. I would like to respectfully point out that Oral Health in school's budget was not cut similarly. Oral health is directly affected by SSB and children, particularly those with disparities, are suffering with decreased access to dentists. Oral health for schools was cut this year, even though services can be offered through learning hubs to those most in need and education can be done remotely. Unfortunately, it will cost more to get the program up again, and there will be more needs, after losing a year of prevention. Thank you for centering around health for our communities.
