Ebola Update

As of Tuesday, November 11, there are no confirmed cases of Ebola in the United States. DPH continues to prioritize Ebola planning and preparation by monitoring the situation closely and taking direct action to ensure the highest level of readiness. This has been, and continues to be, a major team effort. DPH is working with the Department of Emergency Management and other city agencies, as well as the city's public and private hospitals and health care providers on coordination and readiness. The Department Operations Center remains activated and has been meeting several times a week to coordinate, share information, make decisions and take action. DPH continues to provide as much information as possible and encourages everyone to get a flu shot as a measure of protection.

UCSF Develops Site to Make Sense out of Sugar Science

On Monday, November 10, UCSF unveiled a repository of sugar science, designed to collect the evidence against sweetened foods and disseminate that information to the public. The SugarScience Initiative, found at SugarScience.org, is the result of 11 researchers, mostly from UCSF, spending a year poring over thousands of published scientific articles on sugar and its health effects.

Dr. Tomàs Aragòn has been interviewed by the San Francisco Chronicle and KQED regarding the SugarScience repository. He explains that this is just the beginning in understanding the impact sugar has, beyond just the consumption of empty calories.

Asthma Task Force

Presenters slides from the October 10 Asthma Network Forum, "Why Does Toxic Stress Matter to the Prevention and Control of Asthma?" are now accessible on the Asthma Task Force website. Presentations on a range of topics were covered by various speakers from UCSF, a Program Manager at San Francisco Child Abuse Prevention Center and a representative from DPH Environmental Health, Karen Cohn.

PHC 57

This December, Project Homeless Connect (PHC) will mark 10 years of providing life-changing services for San Francisco's most vulnerable individuals. Since its founding in 2004, PHC has

been named a national best practice, seen 1 in 30 San Franciscans volunteer events, and had its model replicated in over 200 cities and 3 countries. To celebrate this success, PHC will host a Breakfast Gala fundraiser, on December 17 at 7:30 a.m.

PHC 57 will take place at Bill Graham Civic Auditorium on December 17 from 10: a.m. to 3 p.m. Whether you have volunteered at a PHC event since our 2004 founding, or if this will be your first time at a PHC event, we hope you'll join us!

DPH Initiative Chosen as a San Francisco Innovation Highlight
