25 Van Ness Avenue, Room 610 is accessible to persons using wheelchairs and others with disabilities. MUNI bus lines serving the area are the 47 (Van Ness), 49 (Van Ness/Mission), 9 (San Bruno), 6 (Haight/Parnassus), 7 (Haight/Noriega), 21 (Hayes). Accessible curbside parking is available on Van Ness Avenue.

In order to assist the city's efforts to accommodate persons with severe allergies, environmental illness, multiple chemical sensitivity or related disabilities, attendees at public meetings are reminded that other attendees may be sensitive to various chemical based scented products. This ordinance assures that deliberations are conducted before the people and that City operations are open to the people's review.
