Wheelchair Accessibility

The first Meeting of the San Francisco Palliative Care Task Force will be held at UCSF Mission Bay, Smith Cardiovascular Research Institute Building, 555 Mission Bay Boulevard, Room S341/42, San Francisco Thursday, May 29, 2014, 10 AM to 12 Noon. The building is wheelchair accessible (for map of the campus, see attached diagram).

The UCSF Mission Bay campus is served by the Muni T-Third Street line, which stops at the UCSF Mission Bay Station located on Third Street near 16th Street. This applies for both north- and southbound travel — that is, going downtown or out to San Francisco's southeast neighborhoods.

All subsequent Task Force Meetings will be held at the Jewish Home, 302 Silver Avenue, San Francisco 94112, which is wheel chair accessible.

The nearest BART station to the Jewish Home is Glen Park BART; exit the station and take the #44 or #52 MUNI bus to Mission and Silver; OR, the Jewish Home is a 5-10 minute walk from the station. If taking MUNI, Mission Street and Silver Avenue is located on MUNI lines #14, #14L, #49, #44, and #52.
