#### 9/11 Observance at San Francisco General Hospital

On September 11, San Francisco Hospital observed the eleventh anniversary of the attacks on the World Trade Center by inviting San Francisco Police Chief Greg Suhr and representatives from the Department of Emergency Management the San Francisco Fire Department to talk to the Management Forum staff about their agencies' disaster preparedness and partnership with San Francisco General Hospital. Chief Suhr highlighted the long-term relationship between SFGH and other first responders, emphasizing that those agencies work closely with one another all year round on trauma and emergencies and the importance of continuing to improve our communication in the event of a real disaster.

#### **Tdap Vaccines for Seventh Graders**

With California schools in the midst of implementing AB 354—the law requiring all 7<sup>th</sup> graders to show proof of Tdap (whooping cough booster shot) by the start of each school year—there is always a need to provide free and last-minute vaccines to kids who are not up to date with their shots. Currently, about 95% of San Francisco 7<sup>th</sup> graders are compliant with the law.In conjunction with the San Francisco Unified School District, San Francisco Department of Public Health Communicable Disease Control Prevention unit held three free Tdap clinics for students who had yet to submit proof of Tdap by September 4<sup>th</sup>. #### **Viral Hepatitis Presentation to China CDC Delegation**

The Department of Public Health receives many requests for presentations from international delegations who are visiting the US. The country we hear from most often is China and the most popular topics are prevention and management of communicable disease and emergency preparedness. Some of the delegations who visit are head of public health departments in China's cities and provinces but occasionally, we are asked to host national-level public health officials.

On Wednesday, August 29<sup>th</sup>, staff from Communicable Disease Control and Prevention Unit (CDCP) and Public Health Emergency Preparedness Response Section (PHEPR), San Francisco Hep B Free Campaign and Project Inform hosted an impressive delegation of the top officials from China's Center for Disease Control and Prevention. A wide range of hepatitis-related topics were presented including Perinatal Hep B and Chronic Hep B & C surveillance, collaboration, and community outreach.

The presentation highlighted the wide disparity of health issues from infancy into adolescents within the African American community.

# 8) DPH REVENUE AND EXPENDITURE REPORT 4<sup>th</sup> QUARTER FY 2011-2012

Greg Wagner, DPH CFO, gave the presentation.

#### Commissioner Comments/ Follow-Up:

Commissioner Sako asked if the personnel costs listed are for new or existing positions. Mr. Wagner stated that most are existing positions but there are new positions included that are related to DRSP compliance.

#### 9) FINAL HEALTHY SAN FRANCISCO REPORT

Tangerine Brigham, Deputy Director of Health and Director of Healthy San Francisco, gave the presentation.

#### Commissioner Comments/ Follow-Up:

Commissioner Taylor McGhee asked whether Ms. Brigham anticipates that the Governor's pending special session on health care reform will have any impact on Health San Francisco. Ms. Brigham stated that the session may revisit a proposed bill that enables the states to develop a third health care option for the uninsured persons between 133% and 200% of the federal poverty line. If the bill is passed in the special session, it would mean that a portion of the current Healthy San Francisco population may have three coverage options based on income: (1) Medi-Cal, (2) Basic Health Plan or (3) California Health Benefits Exchange. The bill was initially proposed due to concerns that the health exchanges may not ensure affordable premiums.

Commissioner Sako thanked Ms. Brigham for the thorough report and asked if Ms. Brigham had anecdotally observed a cost difference per participant in the DPH versus non-DPH medical home in the Healthy San Francisco program. Commissioner Sako added that the manner in which each medical home treats patients including the spectrum of services offered may impact cost. Ms. Brigham stated that the medical home populations can differ based on the percentage of participants that have chronic conditions and that DPH is looking to see if it can do some analysis based on this.

Commissioner Sanchez stated that in the SFGH JCC, the Committee has reviewed patient satisfaction data and pointed out there have been issues with access to outpatient pharmacies. Ms. Brigham stated that the Office of Pharmacy Affairs changed the rule that limited only one pharmacy per clinical site. The DPH has a contract with Walgreens to provide outpatient pharmacy services. The DPH is exploring opportunities to work with Walgreens and expand the number pharmacy sites.

Director Garcia acknowledged the hard work of Ms. Brigham and all the staff working on Healthy San Francisco.

Commissioner Waters, who served as Chair, gave an update on the 9/11/12 SFGH JCC meeting. The Committee met at the SFGH Wellness Center and heard an update on Wellness Center programs including the anti-tobacco initiative. Roland Pickens, SFGH COO, and Director Garcia will be traveling to Denver, Colorado to participate in a seminar on LEAN programs. Director Garcia stated that LEAN is an effective way to study the manner in which services of an institution are delivered.
