The Laguna Honda Psychiatry Service is a multidisciplinary team of behavioral health professionals, including health workers, behavioral health clinicians, psychologists, psychiatrists and support staff. Since 2015 the team has embarked on a transformational journey of designing and implementing a comprehensive behavioral health program aimed at best meeting the service needs of Laguna Honda residents. They have focused on providing evidence-based clinical interventions, added new treatment options, improved substance treatment program, promoted harm reduction and trauma informed principles, established quality measures and streamlined work flow.

In Fiscal Year 17-18, the Psychiatry Service Team provided psychotropic medication management, mental health treatment, substance use treatment and recovery services, neuropsych assessment and testing, and behavioral consultation to 445 Laguna Honda residents. Greater than 95% of e-Consults received by this team were responded to within 5 days of a referral from a primary care attending. 86% of residents surveyed reported the Psychiatry Services received were Excellent/Good. The change journey of the Laguna Honda Psychiatry Services Team reflects the True North values of the San Francisco Health Network, and is a great example of excellent team work. Laguna Honda's Nursing Services partnered with Pharmacy Services to conduct a thorough 5S of the medication storage areas within each neighborhood. The initial project goal was to clean out the medication carts, treatment carts and medication rooms of two pilot units back in January 2018 in order to create a better work environment that would lessen the likelihood of medication errors for residents.

After seeing the positive feedback from staff on the two pilot units, a plan was created to roll out this effort hospital-wide across 13 neighborhoods. There are two medication rooms on each neighborhood, with a medication and a treatment cart in each medication room. The rollout was complete in September 2018 and all neighborhood medication storage areas are now up to the highest standards of 5S just in time for state survey preparation activities. Over a nine month process, a total of 26 medication rooms, 26 medication and 26 treatment carts were reorganized.

The Hospital completed its CMS Recertification Survey on October 15, 2018 with zero medication errors and no substandard quality of care. Congratulations to the 5S Team for their fantastic work!
