Re: *Community Health Care Planning Ordinance Notice for CPMC Pacific Campus, California Campus, and St. Luke's Campus.*

Dear Secretary to the Health Commission:

In accordance with the Community Health Care Planning Ordinance (Proposition Q, 1988), CPMC is required to notice the Health Commission for any closures, changes in management, or reduction of inpatient or outpatient services. As you know, CPMC is anticipating the opening of the CPMC- Mission Bernal Campus in August of this year and the CPMC- Van Ness Campus in March of 2019. In preparation for the moves to our new hospitals, the opening of a new medical office building, the closure of our California Campus, and transition of our Pacific Campus from an inpatient to outpatient campus, we are undergoing some closures and changes in management that we are formally noticing.

I enclose a copy of a public notices announcing the change of management of the following outpatient departments from CPMC to our Sutter affiliated physician foundation, Sutter Pacific Medical Foundation (SPMF):

CPMC- St. Luke's Campus:
Breast Health/Mammography Center,
Non-Invasive Cardiology,
Diabetes Center

CPMC – California Campus:
Diabetes Center

CPMC – Pacific Campus:
Outpatient Psychiatry Clinic

In planning for this shift in services, CPMC and SPMF have been working together to prepare for the transfer in management. We do not anticipate a reduction of services, rather a program transfer to better align our internal resources with patient need.

Furthermore, the Alzheimer's Day Program at the California Campus, which is currently licensed by both CPMC and the Institute on Aging (IOA), will change to independently licensed by IOA, pending approval by the California Department of Social Services. IOA has historically operated the Alzheimer's Day Program and will continue to do so following the change in licensure.

Finally, the Alzheimer's residential care facility at the California Campus will be closing by the end of 2018. We are working with each resident to facilitate their move to another facility within the City of San Francisco. We have worked with Elder Care Alliance to establish a new Alzheimer's residential care facility at their Alma Via Campus and are

working with residents and families to prepare for a move to that facility or a facility of their choice.

Our teams will work with patients, residents, their families, and our community partners to ensure a seamless transition following these changes.
