1) CALL TO ORDER

3) HOUSING CONSERVATORSHIP UPDATE

Angelica Almeida, Ph.D, Director, Forensic/Justice Behavioral Health Services, presented the item.

Dr. Almeida stated that the program works with a range of providers, including the Department of Homelessness and Supportive Housing, to ensure a wide range of wrap-around services are available to this population.

Patrick Chang, Office of Policy and Planning, and Dr. David Pating, MD, San Francisco Health Network Addiction Psychiatric Substance Use Services, presented the item.

Commissioner Giraudo noted that in her experience as a psychologist working with children and youth, there is an increase in drug use among this population. She requested a list of resources in schools. Dr. Pating stated that he would send resources through Mr. Morewitz.
