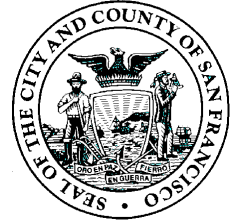

1) CALL TO ORDER

2) APPROVAL OF MAY 15, 2018 COMMUNITY AND PUBLIC HEALTH COMMITTEE MINUTES

Action Taken: The Committee unanimously approved the minutes.

3) BUILDING CAPACITY TO SUPPORT 21ST CENTURY PUBLIC HEALTH

Jonathon Fuchs, MD, MPH, Director of Center for Learning and Innovation, presented the item.

Commissioner Comments:

Commissioners Loyce and Bernal requested an invitation to the SFDPH Summer HIV Research Program (SHARP) symposium. Mr. Morewitz stated that he will follow-up on this request.

Commissioner Bernal asked if SHARP has already begun. Dr. Fuchs stated that the program is in its second week.

Commissioner Bernal asked if the SFDPH is reapplying for its CDC grant. Dr. Fuchs stated that the grant application will be submitted in August. The grant will be used to leverage other funds with external partners.

Commissioner Loyce stated that he appreciates the high level of community involvement in the development of SFDPH policy.

4) SAN FRANCISCO HEALTH NETWORK PRIMARY CARE LEAN UPDATE

Hali Hammer, MD, Director of SFHN Primary Care, presented the item.
