#### RAMS Prop I Community Meeting Minutes - November 2, 2015 from 3-4pm


- The meeting was called to order at 3pm and Tom Mesa expressed the support of the Department for this project and he then introduced Kavoos Bassiri to provide a PowerPoint presentation of the details of this project
- 18 community members attended
- Kavoos Bassiri and staff presented on proposed new location of RAMS "Peer Wellness Center" at 1282 Market Street. Expected opening: February 2016
- History: RAMS has been around for 40+ years, serves 18,000 people in SF, provides behavioral health services, vocational training opportunities, educational services, counseling, outreach, individual and group support, community engagement activities
- Services are provided in over 30 languages
- Peer Wellness Center will be an accessible site, 1<sup>st</sup> level only, easy commute, central location
- Approximately 7,000 square feet with space for services and offices
- This will be a drop-in only center, with no charts, no treatment plans
- Counselors will have personal or family experience with mental health issues
- Staff will be peer counselors, "For the people, by the people"
- Some examples of services to be provided: music group, art group, exercise room, outreach support
- RAMS will provide a healthy, welcoming environment while being mindful about safety, confidentiality, security
- At any given time, approximately 15 staff members will be on site
- Goal of Peer Wellness Center is to connect people to the community, create linkages,
  become a catalyst for people to make these connections
- Site will be handicap accessible
- Will have 1 entrance and 3 points of egress
- Recommendations of community members: surveillance, photocopy ID's, peer safety support person, track duplicated/unduplicated clients, syringe drop boxes in bathrooms, harm reduction model, ideas for traffic flow
- Seek balance between welcoming and secure environment

The meeting was open to the audience to ask questions. Questions were asked about the layout of the site, the safety of staff, capacity limits that the Fire Department may require, the flexibility of morning, afternoon, evening scheduled activities.

Audience was invited to join the community advisory group that the program will be hosting on a regular basis and that those members who signed in with their email will be alerted to when these meeting will be held.

There was no voiced opposition from anyone attending.
