## **Explanation of Service Change and Variances:**

This is a new contract.

### Monitoring Report/Program Review & Follow-up:

The contract services will be monitored by the Department as required. The SFDPH Program Administrator will be responsible for assisting and tracking all information related to the accomplishment of the project.

### Nondiscrimination and Cultural Competency:

The Department will work closely with the contractor to ensure that their cultural competency plan is current and in compliance with Departmental procedures.

### **Sole Source:**

The software license and software maintenance agreement is justifiable according to Section 21.30 of the City's Administrative Code for Software Licenses, Support, Escrow, and Finance and Equipment Maintenance agreements. As confirmed by Hyland Software, the Hyland OnBase product and associated system maintenance is proprietary to Hyland Software Inc. and is not available through other sources.

### **Other Significant Issues:**

As part of the Department of Public Health Electronic Health Record project, the OnBase product will be used by the Department to 1) Archive documents and unstructured data from legacy systems that will be decommissioned with the implementation of Epic. These documents are specific to a patient visit and require access by clinicians and support staff; 2) Electronically capture forms that may remain on paper or that need to be cold fed into the ECM ; and 3) Revenue cycle integration to meet both Medical Records and Patient Financial Services requirements for managing forms, information flow and worklists.
