San Francisco Ordinance 300-10 (effective January 2011)

- Required the creation of a Health Care Services Master Plan (HCSMP)
- Joint effort between DPH & CPC
- Adopted by Health and Planning Commissions and Board of Supervisors

Purpose

- Identify current & future health care needs in SF with a focus on improving equitable access for vulnerable populations
- Identify an appropriate & equitable geographic distribution of facilities
- Provide a framework for reviewing future medical use development projects
- Provide policy recommendations related to health care services as needed

- Land Use Assessment
- Capacity & Gaps Assessment
- Health System Trends Assessment

Consistency Determination Guidelines

Used to evaluate new medical use projects > 5k GSF (or > 10k GSF for change of use)

Supporting Legislation & Policy Recommendations

- Legislation already adopted
- Policy ideas

Highlights major health trends in morbidity and mortality and identifies social determinants of health Land Use Assessment



Analyzes current supply of medical uses, demand and need for new medical uses, and potential land use impacts

IMPLEMENTATION - CONSISTENCY DETERMINATION PROCESS

Consistency Determination Guidelines


- Set of guidelines derived from the findings of the HCSMP
- Requires new facilities to demonstrate how they meet HCSMP goals
- Provides priority processing at Planning for exemplary projects meeting a priority health need

Process

- Projects that must apply to SFDPH for a Consistency Determination:
 - 5,000+ GSF new or added Medical Use
 - 10,000+ GSF change of use to Medical Use
- Not a checklist: providers select the Guidelines relevant to their project.


- Many original findings still hold true today
- Key Updates to Plan Document
 - Updated information on health needs and policies at the local, state, and federal levels
 - Deliberate focus on critical community needs: behavioral health services and longterm care (including SNFs)
- Updates to Consistency Determination Guidelines
 - Consolidated/streamlined list
 - Application to Institutional Master Plans
- Planned Ordinance Changes
 - 10 year update with monitoring reports every five years



KEY FINDINGS - ACCESS FOR VULNERABLE POPULATIONS

 All San Franciscans do not have equal opportunity for good health, and certain neighborhoods and subpopulations experience significant health disparities

- Vulnerable populations
 - Neighborhood
 - Socioeconomic status
 - Age
 - Race/ethnicity
 - language




KEY FINDINGS - BEHAVIORAL HEALTH

 Increased community services are needed for persons with behavioral health challenges

 Estimated that approximately 250,000 San Franciscans experience symptoms of a behavioral health condition.




KEY FINDINGS - POST-ACUTE & LONG-TERM CARE

 San Francisco's growing senior population coupled with a decline in long-term care resources will increase demand for post-acute and long-term care

- Residential Care Facilities (RCFEs) – "Board and Care"






KEY FINDINGS - LAND USE

- 1.75 M sq. ft. major medical added since 2013
- 12,360 new jobs since 2010


- Land Use Trends

 Major population growth is expected in the Bayview, Treasure Island and Parkmerced developments, which are relatively distant from existing healthcare facilities.
