RESOLUTION NO. 4-90

**Resolution on the Transfer
of McKinley Square and Park Aid Station.**

WHEREAS, The voters of the City and County of San Francisco approved a general obligation bond issue in November 1987 to construct a Skilled Mental Health Nursing Facility adjacent to San Francisco General Hospital; and

WHEREAS, There is a small triangle of land that was formerly connected with McKinley Park, before U.S. Highway 101 was constructed, adjacent to the proposed site for this new facility; and

WHEREAS, The Recreation and Park Commission pursuant to Resolution No 6252, adopted on May 13, 1965, declared that it had no further use for the triangular portion of McKinley Square located to the west of the existing James Lick Freeway (known as Lot 3 in Assessor's Block 4091) for either recreation or park purposes; and

WHEREAS, On July 20, 1989 the Recreation and Park Commission adopted Resolution No. 15428 which approved in concept the use of McKinley Square by the Department of Public Health; and

WHEREAS, Within Resolution No. 15428 the Recreation and Park Commission attached a condition that the property in Golden Gate Park known as Park Station currently occupied by the Department of Public Health's Paramedic Division would be vacated, allowing future usage by the Recreation and Park Department; and

WHEREAS, Resolution No. 15428 further identified a condition on the use of McKinley Square be contingent upon the vacation of the Park Station prior to the time of construction would occur for the Skilled Mental Health Nursing Facility; and

WHEREAS, The Paramedic Division of San Francisco General Hospital has determined that Park Station no longer meets the operational needs of the Division; and

WHEREAS, The Health Commission has authorized the Paramedic Division to enter into an agreement to occupy other facilities in the near future; now, therefore, be it

RESOLVED, That the Health Commission accepts the transfer of that portion of McKinley Square previously identified in this resolution from the jurisdiction of the Recreation and Park Department and authorizes the Director of Health to execute all necessary documents; be it

FURTHER RESOLVED, That the Health Commission authorizes the Director of Health is hereby authorized to execute any and all documents necessary to transfer jurisdiction of Park Station from the Department of Public Health to the Recreation and Park Department of the City and County; and, be it

FURTHER RESOLVED, That the Director of Property of the City and County of San Francisco is hereby requested to prepare all necessary legislation to transfer Lot 3 in Assessor's Block 4091 (Portion McKinley Square) to the Department of Public Health and arrange for the transfer of the parcel of land in Golden Gate Park fronting on Stanyan Street (Park Station) from the Department of Public Health to the Recreation and Park Department.
