2. APPROVAL OF MINUTES FOR MEETING OF MAY 14, 2019

Action Taken: The minutes were unanimously approved.

3. GENERAL PUBLIC COMMENT:

Dr. Derek Kerr, presented and submitted the following written comment: Perhaps you didn't notice, but you were shown this chart at the May 14 meeting. It shows that between March 2018 and March 2019, 177 patients were discharged to the community. Of these, 57 or 1 out of 3 fled by going AWOL or AMA. Although 11 of the 43 AWOL cases eventually returned, that's still the highest percentage ever of "unplanned discharges" - patients who ran away. Previously, Commissioner Chow recommended that LHH ask these escapees why they left. Yet the 5/14/19 meeting minutes don't show explanations from staff or inquiries from Commissioners. It's amazing to see these unprecedented and increasing numbers. More amazing is seeing this phenomenon escalate without explanation or redress.
