The meeting was called to order at 1:02pm.

2) APPROVAL OF MINUTES FOR MEETING OF APRIL 22, 2014

<u>Action Taken</u>: The minutes of the April 22, 2014 LHH JCC meeting were unanimously approved.

3) HOSPITAL REPORT

Mivic Hirose, Executive Administrator, gave the report.

Public Comment:

Dr. Derek Kerr submitted the following written comment:

Under "Wellness" in the Administrator's Report we read that "Active Shooter Response" trainings are underway. Is this due to the Flow Project's influx of SFGH patients? Last month, SFGH was on lockdown after a shooting; 3 men were arrested. After the first Flow Project we saw violence,

a gunman chased by LHH Police, and a 30-bed Ward demolished by arson. Drug-Sniffing dogs are being deployed at LHH. What happened to the Substance Abuse Treatment Services? Are they too busy battling tobacco to control meth and crack? What does this say about the drugs and patients flowing into Laguna Honda? Police dogs should interdict drug traffickers - not elderly or physically disabled residents. Disruptive patients should have their own "Neighborhood" - staffed with a Police Officer, SATS counselors and trained nurses. Otherwise, you undermine the autonomy, safety and home-like environment the majority deserves.

4) FY 2013-14 3rd QUARTER FINANCIAL REPORT

ChiaYu Ma, Deputy Financial Officer, gave the report.

Public Comment:

Dr. Derek Kerr submitted the following written comment:

The Gift Fund report shows specialty units like Hospice and Positive Care spending thousands to enhance quality of life for their residents. Others, like the Asian Focus Units and the Dementia Care Program spend nothing. Why don't these unique cultural and behavioral Neighborhoods receive similar support? The Adult Day Health Care sub-fund holds \$1,400. But LHH closed its ADHC Program 5 years ago. It's the only sub-fund without beneficiaries - and controlled by the CEO. This year's Gift Fund budget allocated \$45,000 for bus trip outings. Most of the year has passed, yet only \$21,000 was spent. This month, LHH paid for a Taco Bar Celebration for the Leadership Team and a shin-dig for Nursing Week. In 2009, Nursing used \$8,000 from the Patient Gift Fund to purchase gourmet food, games and pedometers for staff. We still get media inquiries about the Gift Fund. Hopefully, rules are being followed.

5) PATIENT FLOW PRESENTATION

Janet Gillen, Director of Social Services, gave the presentation.

Commissioner Comment/Follow-Up:

Commissioner Sanchez stated the presentation was excellent and a good example of integrating systems within the San Francisco Health Network. He requested that in future presentations, the data in category "Other" be listed.

Commissioner Karshmer stated that the report shows shift in paradigm and effective use of integrating resources throughout the SFDPH.

6) CONSIDERATION OF HOSPITAL-WIDE POLICIES AND PROCEDURES

Mivic Hirose, Executive Administrator, introduced the policies and procedures.

<u>Commissioner Comments/Follow-Up:</u>

Commissioner Sanchez requested that a redline copy of all draft policies be provided to the Commissioners on the day of the meeting.

Action Taken: The LHH JCC unanimously approved the hospital-wide policies and procedures.

On March 24, the Controller released an audit titled: "Internal Controls at Laguna Honda Hospital's Central Supply Department Do Not Ensure That Assets Are Properly Accounted for and Safeguarded". It found numerous lapses, and recommended written policies. Since reports that critique LHH management are withheld from JCC meeting agendas, I provided the Executive Summary to the Commissioners.
