Psychiatry Clinical Service Rules and Regulations, Policies and Procedures *(copy emailed to Commissioners)*

MEC approved changes to the Psychiatry Rules and Regulations, which were largely editorial. One significant change is on the Psychiatry Privilege List: The age of patients covered by the Service's Adult Core privileges, from 18 to 16. See below:

ADULT (CORE) PRIVILEGES-PSYCHIATRISTS (MD/DO)

Diagnostic assessment and treatment of psychiatric and substance abuse disorders; including mental status exam; treatment planning; individual psychotherapy; group psychotherapy; family psychotherapy; emergency psychiatry assessment and treatment; crisis management; evaluation of medical status; use of psychotropic drugs approved by the FDA; detoxification following substance abuse; and behavior modification of patients **16** years and older.

This change was made primarily to bring the Service into alignment with core adult privileges at Langley Porter. This change was discussed with the Psychiatry medical staff who were in agreement.

Interim Surgery Service Chief

The ZSFG Medical Staff Bylaws require approval of the MEC, Vice Dean, and the Governing Body of an appointment as Acting Chief of a Clinical Service for more than ninety days. In compliance with this requirement, MEC approved the appointment of Dr. Steven Nishmura as Interim Chief of the ZSFG Anatomic Pathology Service. *(CV emailed to Commissioners)*

Credentials Committee Items

Anesthesia Privilege List Revisions: *(Copy Attached)*

- Addition of 6.11 Preoperative evaluation privileges for anesthesia providers who work solely in the pre-op clinic doing preoperative evaluation but are not providing anesthesia in the OR.
- Language added to 6.10 Core Privileges to clarify that Core privileges include 6.11 and anesthesiologists who already have 6.10 do not need to request 6.11.

- Changed Eberhard Fiebig, MD, Director to Barbara Haller, MD,Phd, Interim Director
- Simplified A. Goals and Objectives (Section A)
- Omit reference to Fellowship education in Public Health Microbiology, Section VII
- Update Lab Medicine Service Org Chart (add Core Lab)
- Deleted reference to "Community Health Network, CHN" in the Clin Lab Director's job description
- Updated Attachment B. Resident's packet

Laboratory Medicine Reference Laboratories and Blood Source *(Copy Attached)*

Per Joint Commission requirements, MEC approved the list of reference laboratories for laboratory tests (revised 09/05/16) that cannot be performed in-house. MEC also approved Dr. Haller's recommendation to continue the hospital's current contract with Blood Centers of the Pacific (BCP) in San Francisco as the source facility for blood and blood products. BCP is an FDA-registered, AABB-accredited facility, which has been the hospital's blood supplier for over 50 years.

MEC approved the list of SFGH Clinical Laboratory Critical Values presented by Dr. Haller. The values have been adopted in consultation with the medical staff.
