**Romain C. Pirracchio MD, Appointment as Anesthesia Service Chief:**

**Kieron Leslie, MD, Appointment as Interim Dermatology Service Chief**

Dr. Toby Maurer, Dermatology Chief, will be on sabbatical from September to November 2018. In her absence, Dr. Claire Horton, in consultation with the Dr. Maurer, appointed Dr. Kieron Leslie as Interim Chief of the Dermatology Service at ZSFG. MEC approved the appointment of Dr. Kieron Leslie as Interim Chief of the Dermatology Service from September to November 2018. **Toby Maurer, MD – Re-Appointment as Service Chief of Dermatology Service at ZSFG**

The ZSFG Medical Staff Bylaws 9.2.3 states that Chiefs of Clinical Services shall be reviewed every five (5) years or at any time as requested by the Chief of Staff, the Vice Dean, or the Chief Executive Officer. The majority vote of MEC and the Governing Body is required to reappoint a Chief of Clinical Service. MEC approved the COS recommendation to reappoint Dr. Toby Maurer as the Service Chief of the ZSFG Dermatology Service.
